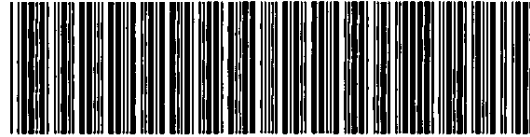



Again, please allow us to form the new LLC as Saint Cross LLC as we release the name Saint Cross and will not reinstate Saint Cross Corporation in the future.


