

**ARTICLE I - NAME**

**THE NAME OF THIS** Limited Liability Company shall be **6404 FINANCIAL , LLC**



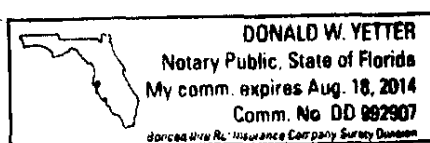


