ARTICLES OF AMENDMENT
TO ARTICLES OF ORGANIZATION
OF

The street address of the principal office of the Limited Liability Company is 407 South Aurora Avenue, Clearwater, Florida.

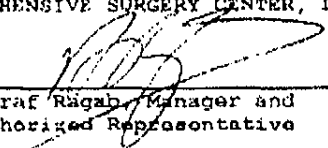
The mailing address of the Limited Liability Company is 1988 Gulf to Bay Boulevard, Clearwater, Florida 33765"
