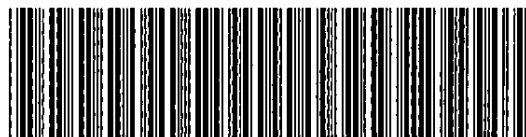

ARTICLE I - Name:

The name of the Limited Liability Company is 1013 DREW, LLC.

The period of duration for 1013 Drew, LLC shall be perpetual.

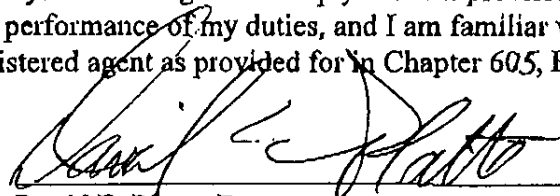
ARTICLE IV - Registered Agent:
