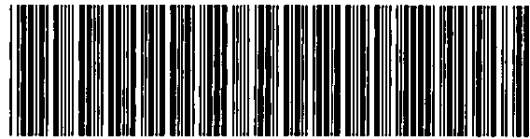

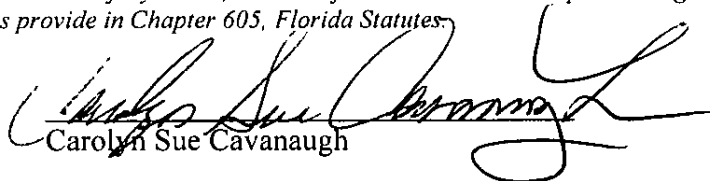

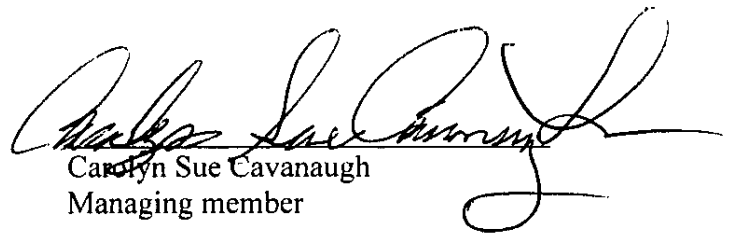
In addition to the foregoing, The Limited Liability Company may transact and engage in any other lawful business not prohibited by statute or law.
