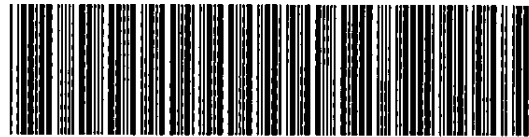

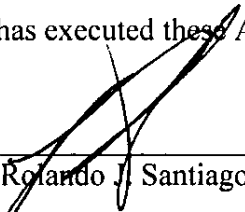
**ARTICLE VIII

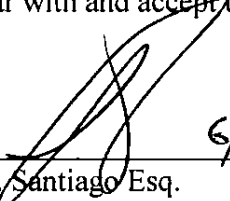
