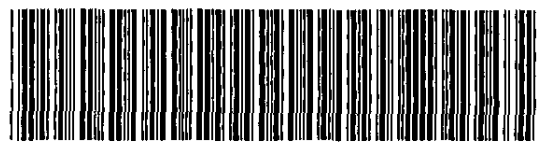

The period of duration for 110 MLK, LLC shall be perpetual.

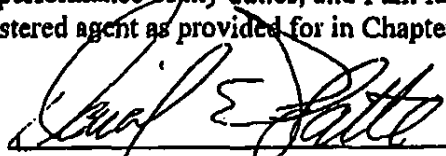
