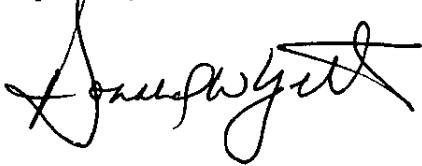

**ARTICLES OF ORGANIZATION OF
WELDING & MATERIALS, LLC**

ARTICLE I - NAME

THE NAME OF THIS Limited Liability Company shall be **WELDING & MATERIALS, LLC.**

ARTICLE II - ADDRESS

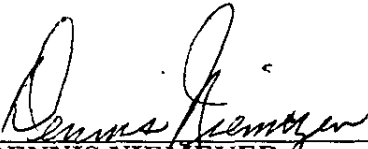

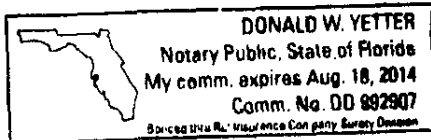

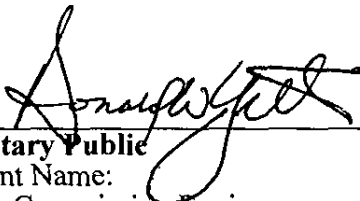
