NCF-JBM3, LLC, a Florida limited liability company, hereby presents these Articles of Dissolution evidencing the dissolution and discontinuation of business of NCF-JBM3, LLC, and sets forth the following pursuant to the provisions of Section 605.0707, *Florida Statutes*:

1. The name of the limited liability company is NCF-JBM3, LLC (the "LLC").
2. The Articles of Organization of the LLC were filed on July 1, 2014 and assigned document number L14000105289.
3. The dissolution was unanimously approved by the members and manager of the LLC on June 1, 2016.




