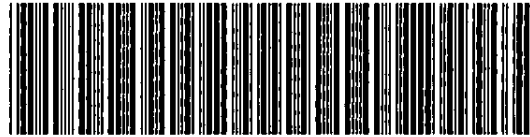



**ARTICLE I - NAME**

**THE NAME OF THIS** Limited Liability Company shall be **1301 FINANCIAL, LLC**

**ARTICLE II - ADDRESS**

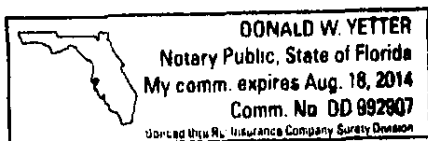


