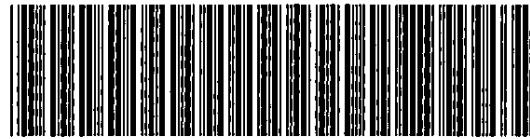



**ARTICLES OF ORGANIZATION FOR
CRAWFORD BROTHERS, LLC
A FLORIDA LIMITED LIABILITY COMPANY**

The undersigned, desiring to form a limited liability company under and pursuant to Florida Statute Chapter 605 entitled the Florida Revised Limited Liability Company Act, do hereby adopt the following Articles of Organization for such company:

1. Name. The name of this company shall be **CRAWFORD BROTHERS, LLC**

2. Duration/Continuation. The period of this company's duration shall be perpetual unless terminated by the unanimous written agreement of all members.

3. Address. The mailing and street address of the company is **5150 NW 86th Trail, Lake Butler, FL 32054**.


10. Additional Capital Contributions. Each member shall make additional capital contributions to the Company only upon the unanimous consent of all the members.


