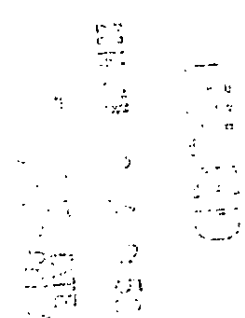
The purpose of this limited liability company is to engage in any and all business not prohibited by the laws of the State of Florida.

ARTICLE VII - ADMISSION OF ADDITIONAL MEMBERS



ARTICLE IX - EFFECTIVE DATE


Pursuant to the provisions of Chapter 605, Florida Statutes, this limited liability company shall begin in existence upon the filing of these Articles of Organization.
