The transferee of interest of any member shall have no right to participate in the management of the business and the affairs of the Professional Limited Company or to become a member without unanimous written consent of all of the remaining members. The transferee shall be entitled to receive only the share of profits or other compensation by way of income or return of contributions to which that member otherwise would be entitled. Only duly licensed dentists shall be eligible to purchase membership interests in this Professional Limited Company.

ARTICLE IX

PROFITS AND LOSSES

The members of this Professional Limited Company shall be entitled to the net profits arising from the operation of the company business. Each member shall be entitled to his or her distributive share of the profits according to his or her pro rata contribution to capital and interest in the Professional Limited Company. Losses shall be passed through to each member in the same proportion according to his or her pro rata interest in the company.

ARTICLE X

WITHDRAWAL, RETIREMENT, DEATH, BANKRUPTCY OR EXPULSION

In the event of withdrawal, retirement, death, bankruptcy or expulsion of a member, this Professional Limited Company shall cease doing business and its existence shall terminate unless the remaining members, by written unanimous consent, agree to the continuation of the business.


ARTICLE XI


