ARTICLES OF ORGANIZATION
FOR

(HEREBY RE-NAMED PELICAN DENTAL, PLLC)

The undersigned, William E. Sackheim, D.M.D., a natural person competent to contract and the sole member of Pelican Dental, LLC, a Florida limited liability company (the "Company"), hereby presents these Amended and Restated Articles of Organization pursuant to the provisions of Section 605.0202, *Florida Statutes*. These Amended and Restated Articles of Organization have been duly adopted by the sole member of the Company.

FIRST: The Company's Articles of Organization were filed on July 3, 2014, with an effective date of July 2, 2014, with the Florida Department of State and assigned document number L14000106777.

SECOND: The Company desires to amend and restate its Articles of Organization to reflect that the Company is a professional limited liability company under the provisions of Chapters 605 and 621, *Florida Statutes*.

THIRD: The Articles of Organization are superseded in their entirety by the provisions of these Amended and Restated Articles of Organization.

FOURTH: The Company's Amended and Restated Articles of Organization are set forth in their entirety as follows:

ARTICLE I - NAME

The name of this professional limited liability company shall be:

ARTICLE II - PRINCIPAL OFFICE ADDRESS

ARTICLE III - PURPOSES AND POWERS

ARTICLE VI - MANAGEMENT

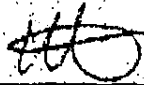

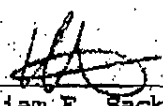
