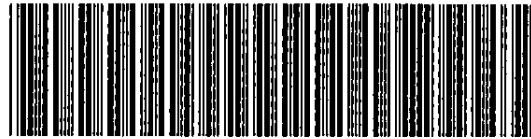

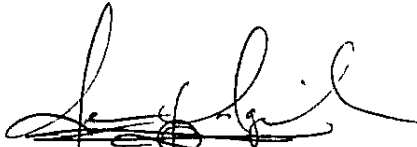

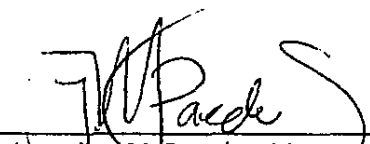
Article IV. Management

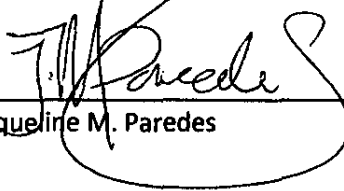
