**ARTICLES OF ORGANIZATION OF  
VLCC, LLC**

The undersigned, Charles E. Chapleau, M.D., a natural person competent to contract and member of VLCC, LLC, hereby presents these Articles of Organization for the formation of a limited liability company under the provisions of Chapter 605, *Florida Statutes*.

**ARTICLE I**

The name of the limited liability company is:

VLCC, LLC

This limited liability company is referred to in these Articles of Organization as the "Company."

**ARTICLE II - PRINCIPAL OFFICE ADDRESS**

The mailing address and street address of the principal office of the Company's initial principal office is 1717 North E Street, Suite 401, Pensacola, Florida 32501.

**ARTICLE III - PURPOSES AND POWERS**

The Company is organized for any legal and lawful purpose for which a limited liability company may be organized and shall have all powers and rights which a limited liability company may exercise pursuant to Chapter 605, *Florida Statutes*.

**ARTICLE IV - COMMENCEMENT AND TERM OF EXISTENCE**

The date for commencement of the Company's existence shall be the date these Articles of Organization are filed with the Florida Department of State, and the Company shall have a perpetual existence unless the Company is terminated as provided in its Operating Agreement.

**ARTICLE VI - MANAGEMENT**

A member may not sell or otherwise transfer his or her interest in the Company, whether represented by membership units, certificates, or a percentage interest in the Company, until the member has complied with the restrictions, including a right of first refusal, contained in the Operating Agreement for the Company.
