The undersigned, Jean Noel Mignot, a natural person competent to contract and a member of JN Mignot, LLC, hereby presents these Articles of Organization as the Articles of Organization of JN Mignot, LLC, a limited liability company formed under the provisions of Chapter 605, *Florida Statutes*.

ARTICLE I - NAME


