ARTICLES OF ORGANIZATION

OF

QUEANH PHAN, D.M.D., PLLC,

A FLORIDA PROFESSIONAL LIMITED LIABILITY COMPANY

*The undersigned, for the purpose of forming a professional limited liability company under the Florida Professional Service Corporation and Limited Liability Company Act, Chapter 621, Florida Statutes and the Florida Revised Limited Liability Company Act, Chapter 603, Florida Statutes (collectively, the "Acts"), hereby makes, acknowledges, and files the following Articles of Organization.*

ARTICLE I - NAME

The name of the limited liability company shall be QUEANH PHAN, D.M.D., PLLC, a Florida Professional Limited Liability Company (the "Company").

ARTICLE II - ADDRESS

The mailing address of the initial principal office of the Company shall be 7573 Thornlee Drive, Lake Worth, Florida 33467.

ARTICLE III - DURATION

The Company shall commence its existence on the date these Articles of Organization were filed by the Florida Department of State. The Company's existence shall be of indefinite duration. The Company may be dissolved as provided in the Company's operating agreement (the "Operating Agreement").

ARTICLE IV - REGISTERED OFFICE AND AGENT

The name and street address of the initial registered agent of the Company, in the State of Florida, are Salvatori, Wood, Buckel, Carmichael & Lottes, 9132 Strada Place, Fourth Floor, Naples, Florida 34108.

ARTICLE V - PURPOSE

The Company may engage in each and every aspect of the general practice of dental medicine and such other activities related to or incidental thereto, but only through its members, officers, employees, and agents who are duly licensed or otherwise legally authorized to render such professional services in the State of Florida.

ARTICLE VI - MANAGEMENT

The Sole Member is duly licensed in the State of Florida to render professional services for which the Company is organized. The Operating Agreement may contain any provisions for the regulation and management of the affairs of the Company not inconsistent with the Acts or these Articles of Organization; provided that no person may vote or be delegated the power to vote the member interests in the Company other than the Sole Member.

#### ARTICLE VII -- ALIENATION OF MEMBER INTERESTS

No person shall be admitted as a member of a limited liability company organized under this act, unless such person is a professional corporation, a professional limited liability company, or an individual, each of which must be duly licensed or otherwise legally authorized to render the same specific professional services as those for which the Company is organized. No member of a limited liability company organized under this act shall enter into any type of agreement vesting another person with the authority to exercise any of that member's voting power in the limited liability company.
