**ARTICLES OF ORGANIZATION  
OF

The Undersigned, acting as organizer for the purpose of forming a limited liability company under the Revised Florida Limited Liability Company Act, Fla. Stat. Chapter 605, hereby make, acknowledge, and file the following Articles of Organization;

**ARTICLE I.  
NAME**

**ARTICLE II.

**ARTICLE X.  
MANAGEMENT**

The Company shall be managed by a **manager** or **managers** in accordance with the Articles of Organization, the Operating Agreement, the Regulations adopted by the

**ARTICLE XI.  
LIMITATION ON AGENCY AUTHORITY OF MEMBER**




