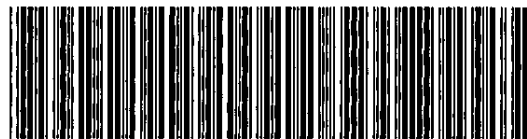

Name


ARTICLE VIII
