**ARTICLES OF ORGANIZATION
OF
CC OHIO HOLDINGS, LLC**

The undersigned, for the purpose of forming a limited liability company under the Florida Revised Limited Liability Company Act, F.S. Chapter 605, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE I

Name. The name of the limited liability company shall be **CC OHIO HOLDINGS, LLC** ("Company").

ARTICLE II

Address. The mailing address and street address of the principal office of the Company shall be 950 S. Winter Park Drive, Suite 100, Casselberry, FL 32707.

ARTICLE III

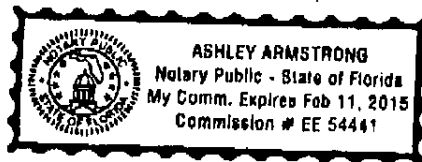
