ARTICLE I
Name of Limited Liability Company

The name of this limited liability company is NIGHTINGALE HOLDING, LLC (the "Company"), with its principal place of business being located at 1475 Shadowmoss Circle, Lake Mary, Florida 32746 and the mailing address is the same.

ARTICLE II
Duration

The Company shall exist from the date of filing of these Articles of Organization with the Department of State until the earlier of fifty (50) years from the date of filing or the occurrence of any of the events specified in Chapter 605, Florida Statutes, unless continued by the unanimous consent of all of the remaining members.

ARTICLE III
Purpose

The Company is organized for the purpose of transacting all lawful activities and businesses that may be conducted by a limited liability company under the laws of Florida.

a member in the Company, the Company shall be dissolved unless the remaining members, by unanimous written agreement, consent to continue the business of the Company.

ARTICLE VII
Management of the Company

The management of the Company shall be by a Manager or Managers elected by the Members as provided in the Operating Agreement. The Company shall be managed in accordance with the Regulations and Operating Agreement adopted by the members. The name and address of the initial managers are:

Regulations

ARTICLE X
Transfer of Interest

If the non-transferring members do not approve the transfer, the transferee of the interest of the transferring members shall have no right to become a member or to participate in the management of the business and the affairs of the Company. The transferee shall be entitled to receive only the share of profits or other compensation by way of income, and the return of contributions to which the transferring member otherwise would be entitled by virtue of membership.

ARTICLE XI
Certificated Interests

The members' interests in the Company shall be evidenced by certificates.

ARTICLE XII
Contracting Debts

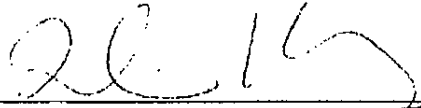

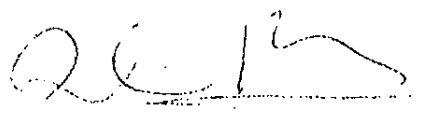
