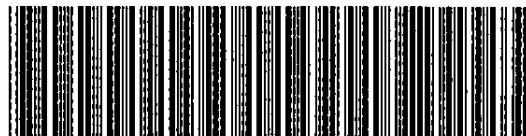



ARTICLES OF ORGANIZATION
OF
FLORIDA MOBILE SODABLASTING, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Chapter 605, Florida Statutes, hereby makes, acknowledges and files these Articles of Organization.

ARTICLE I - NAME

The name of the Limited Liability Company shall be FLORIDA MOBILE SODABLASTING, LLC ("Company").

ARTICLE II - ADDRESS
