**ARTICLES OF ORGANIZATION  
OF

The undersigned, being the sole Member, desiring to form a limited liability company under and pursuant to the Florida Limited Liability Company Act, Chapter 605, Florida Statutes (the "Act"), does hereby adopt the following Articles of Organization:

**ARTICLE I. NAME**

The name of the limited liability company is CONCESSIONS BY CELINE, LLC (the "Company").

**ARTICLE II. ADDRESS**


**ARTICLE VI. PURPOSE**
