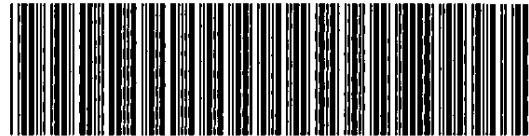



ARTICLE I -- NAME

ARTICLE IV -- REGISTERED OFFICE AND AGENT




