STATE OF FLORIDA ARTICLES OF MERGER OF MOROSO INVESTMENT PARTNERS, LLC (FL) WITH AND INTO PALM BEACH INTERNATIONAL RACEWAY, LLC (FL)

Pursuant to Section 1025 of the Florida Revised Limited Liability Company Act (Chapter 605, Florida Statutes), each of the undersigned merging entities executed the following Articles of Merger:

FIRST: The name of the entity being merged into the surviving limited liability company is Moroso Investment Partners, LLC, a limited liability company organized under the laws of the State of Florida.

SECOND: The name of the surviving entity is Palm Beach International Raceway, LLC, a limited liability company organized under the laws of the State of Florida.

SIXTH: The merger is to become effective on the date of filing.

SEVENTH: The Agreement and Plan of Merger is on file at 825 Parkway Street, Suite 4, Jupiter, Florida 33477, the principal place of business of the surviving limited liability company.
