**ARTICLES OF ORGANIZATION OF  
JBW ENTERPRISES OF NORTHWEST FLORIDA, LLC**

The undersigned, Joshua B. Ward, a natural person competent to contract and a member of JBW ENTERPRISES OF NORTHWEST FLORIDA, LLC, hereby presents these Articles of Organization for the formation of a limited liability company under the provisions of Chapter 605, *Florida Statutes*.

**ARTICLE I**

The name of the limited liability company is JBW ENTERPRISES OF NORTHWEST FLORIDA, LLC. This limited liability company is referred to in these Articles of Organization as the "Company."

**ARTICLE II - PRINCIPAL OFFICE ADDRESS**

The mailing address and street address of the Company's initial principal office is 5860 Staff Road, Crestview, Florida 32536.

**ARTICLE III - PURPOSES AND POWERS**

The Company is organized for any legal and lawful purpose for which a limited liability company may be organized and shall have all powers and rights which a limited liability company may exercise pursuant to Chapter 605, *Florida Statutes*.

**ARTICLE IV - COMMENCEMENT AND TERM OF EXISTENCE**

The date for commencement of the Company's existence shall be July 16, 2014. The Company shall have a perpetual existence unless the Company is terminated as provided in its Operating Agreement.

**ARTICLE V - INITIAL REGISTERED OFFICE AND AGENT**

A member may not sell or otherwise transfer his or her interest in the Company, whether represented by membership units, certificates, or a percentage interest in the Company, until the member has complied with the restrictions, including a right of first refusal, contained in the Operating Agreement for the Company.

**ARTICLE IX - AMENDMENT**

Unless otherwise provided in the Operating Agreement for the Company, these Articles of Organization or any amendment thereto may be amended in accordance with the Florida Revised Limited Liability Company Act, as it presently exists or may hereafter be amended.
