ARTICLES OF ORGANIZATION OF

JBW ENTERPRISES OF NORTHWEST FLORIDA, LLC

The undersigned, Joshua B. Ward, a natural person competent to contract and a member of JBW ENTERPRISES OF NORTHWEST FLORIDA, LLC, hereby presents these Articles of Organization for the formation of a limited liability company under the provisions of Chapter 605, Florida Statutes.

<u>ARTICLE I</u>
