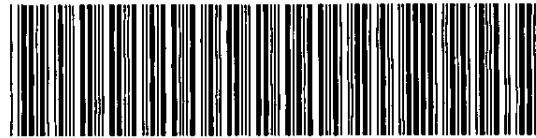

FIRST: The Articles of Organization for the Company were filed on July 21, 2014, and assigned Document No L14000115039.


SECOND: The following amendment(s) to the Articles of Organization have been adopted by the limited liability company:
