# ARTICLES OF ORGANIZATION PELICAN BAY DEVELOPERS, LLC

The undersigned, desiring to form a limited liability company under and pursuant to Chapter 605 of the Florida Statutes, entitled the Florida Revised Limited Liability Company Act, do hereby adopt the following Articles of Organization for such company.

# ARTICLE I NAME

The name of the limited liability company, hereinafter referred to in these Articles as "Company," is PELICAN BAY DEVELOPERS, LLC.

#### ARTICLE II **ADDRESS**

The Company's street address of its principal place of business in Florida is 705.
