CATCHLIGHT CONSULTING, LLC**


Pursuant to the provisions of Florida Statutes Section 605.0707, CATCHLIGHT CONSULTING, LLC (the "Company") adopts the following articles of dissolution for the purpose of dissolving the company.

1. The name of the company is CATCHLIGHT CONSULTING, LLC. The Company's Articles of Organization were filed with the Florida Department of State on July 21, 2014, and the Company's document number is L14000115984.

6. The effective date of the dissolution is the date of the filing of these Articles of Dissolution.
7. Upon the filing of these Articles of Dissolution, the Company shall cease conducting its business and shall continue solely for the purpose of winding up its affairs, as needed, in accordance with Florida Statutes Section 605.0709, except for the purpose of lawsuits, other proceedings, and appropriate action as provided in Florida Statutes Chapter 605.
