The undersigned, for the purpose of forming a limited liability company understhe Plorida Revised Limited Liability Company Act, pursuant to Chapter 605 of the Florida Statutes, hereby makes, acknowledges and files the following Articles of Organization (the "Articles").

ARTICLE I NAME

The name of the limited liability company is VISION B, LLC (the "Company").

ARTICLE II MAILING AND STREET ADDRESS

The mailing address and street address of the principal office of the Company shall be 3811 SE 47th Ave., Suite 623, Davic, Florida 33314.

ARTICLE III REGISTERED AGENT AND OFFICE

ARTICLE VII MANAGEMENT; INITIAL MANAGER

The Company shall be a manager-managed limited liability company and shall be managed in accordance with the Operating Agreement adopted by the members for the management of the business and affairs of the Company. The Operating Agreement may contain any provisions for the regulation and management of the business and operations of the Company, not inconsistent with Florida law or the Articles. The name and address of the Company's manager that is authorized to manage and control the Company shall be Jose Russoniello, 3811 SE 47th Ave., Suite 623, Davie, Florida 33314.

ARTICLE VIII AMENDMENT

The Articles may be amended only in accordance with the Operating Agreement.
