ARTICLES OF AMENDMENT
TO ARTICLES OF ORGANIZATION
OF
NNKR, LLC

The undersigned being a Member of NNRK, LLC., a Florida limited liability company (the "Company"), in accordance with the provisions of Chapter 605, Florida Statutes, hereby amends its Articles of Organization as set forth below:

1. The name of the Company is NNRK, LLC.
2. The Articles of Organization for the Company were filed with the Florida Department of State on July 24, 2014.
3. Article V of the Company's Articles of Organization is hereby deleted in its entirety and the following is substituted therefor:

"ARTICLE V.

"The Limited Liability Company shall be managed by one or more managers and is, therefore, a manager-managed limited liability company. The authority and duties of the Manager shall be as set forth in the Operating Agreement of the Limited Liability Company. The name and address of the initial Manager is Nermin K. Rubin, 5795 Ulmerton Road, Suite 200, Clearwater, FL 33760."

4. These Articles of Amendment shall be effective upon filing with the Florida Department of State.
5. These Articles of Amendment have been approved by unanimous Written Action of the Members dated May 20, 2015, which vote is sufficient for approval.
6. Except as expressly provided herein, all of the terms and provisions of the Articles of Organization shall remain in full force and effect and are hereby ratified and confirmed.

The execution of these Articles of Amendment of the Articles of Organization by the undersigned constitutes an affirmation under the penalties of perjury that the facts stated herein are true and correct.
