**ARTICLES OF ORGANIZATION
OF
SKY POWERSPORTS NORTH ORLANDO, LLC**

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act (Chapter 608 of the Florida Statutes), hereby makes, acknowledges, and files the following Articles of Organization.

**ARTICLE I
NAME**

The name of this limited liability company is Sky Powersports North Orlando, LLC, a Florida limited liability company (the "company").

**ARTICLE II
ADDRESS**

PURPOSES AND POWERS

This company is organized for the purpose of transacting any and all lawful business for which limited liability companies may be formed under the Florida Limited Liability Company Act.
