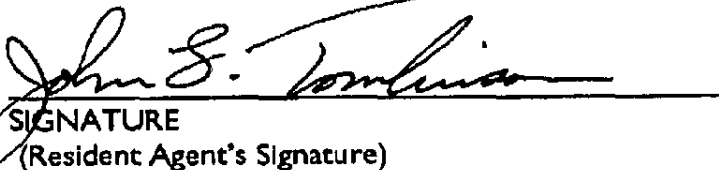

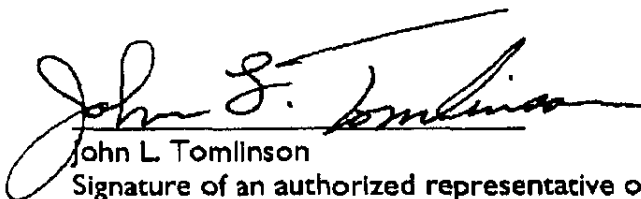

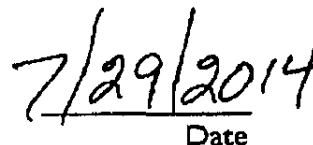
ARTICLE VII - PRE-EMPTIVE RIGHTS
