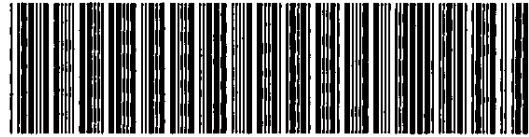

The Company is to be managed by one or more managers, and is, therefore, a manager-managed company. The name and address of the initial manager is:

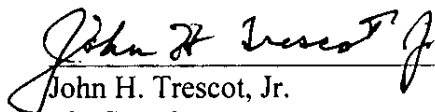

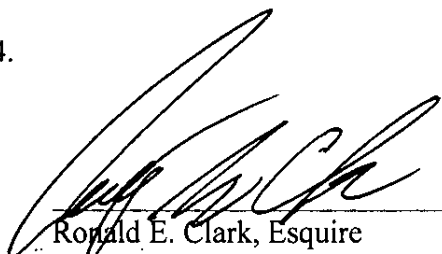

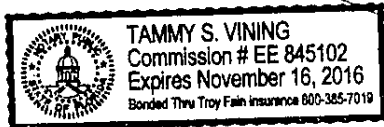
