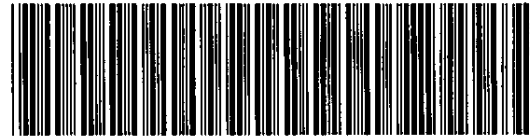

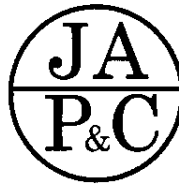

FIRST: The name of the company is currently **KIDS CARE OF DAVENPORT, PLLC.**


SECOND: The following Amendment to the Articles of Organization was adopted by the company, changing the name of the company:
