**ARTICLES OF ORGANIZATION
OF

The Undersigned, being a member, desiring to form a Limited Liability Company under and pursuant to the Florida Limited Liability Company Act, Chapter 605, Florida Statutes, does hereby adopt the following Articles of Organization.

ARTICLE I

ADDITIONAL MEMBERS




