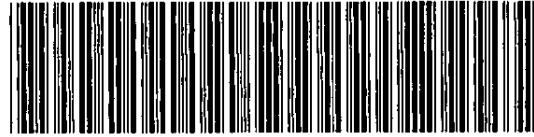

ARTICLE III - Management


The Company shall be managed by its member, and is therefore a member-managed Company.
