**ARTICLES OF ORGANIZATION
OF
FLOW CONTROL PLUMBING, LLC**

The undersigned, desiring to form a limited liability company under and pursuant to Chapter 605 of the Florida Statutes, entitled the Florida Revised Limited Liability Company Act, do hereby adopt the following Articles of Organization for such company.

**ARTICLE I
NAME**

The name of the limited liability company, hereinafter referred to in these Articles as "Company," is Flow Control Plumbing, LLC.

**ARTICLE II
ADDRESS**

The Company's street address of its principal place of business in Florida is 5280 Deer Creek Drive, Pace, FL 32571, and its mailing address is 5280 Deer Creek Drive, Pace, FL 32571, but it shall have the power and authority to establish branch offices at such place or places as may be designated by the Manager.

**ARTICLE III
MANAGEMENT**

New members may only be admitted as provided in the Operating Agreement of the Company. A member's interest in the Company may only be sold or transferred as provided in the Operating Agreement of the Company.




