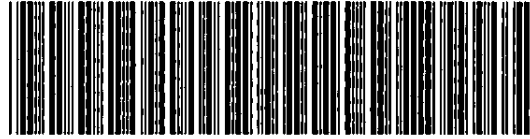




ARTICLE IX

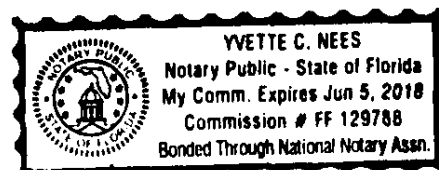
