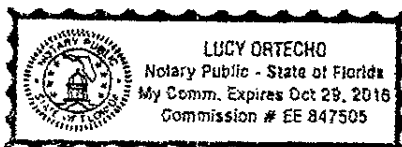
Before me, a notary public, appeared JAYA SYLVIA VERMA, who after first being duly sworn, deposes and states as follows:
