ARTICLES OF ORGANIZATION
OF
URA LLC

The undersigned hereby submits these Articles of Organization (these "*Articles of Organization*") for purposes of forming URA LLC, a Florida limited liability company, under the Florida Revised Limited Liability Company Act, Chapter 605, *Florida Statutes*.

ARTICLE I - Name:

The name of the limited liability company formed pursuant to the filing of these Articles of Organization is URA LLC, a Florida limited liability company (the "*Company*").

ARTICLE II - Address:

The mailing address and the street address of the principal office of the Company is 192 NE Cypress Trail, Jensen Beach, FL 34957.

ARTICLE III - Duration:

The period of duration for the Company shall be perpetual, unless dissolved in accordance with the terms of the Operating Agreement of the Company.

ARTICLE IV - Management:

The Company shall be managed by a manager elected from time to time in accordance with the Operating Agreement of the Company (the "*Manager*"), and the name of the individual who is to serve as initial Manager is John Steven Hamilton. Except for those persons, if any, elected in accordance with the Operating Agreement of the Company, the Company shall not have any officers other than the Manager.

ARTICLE V - Adoption of Operating Agreement:

The Company shall be governed by a written Operating Agreement adopted by its member(s), which Operating Agreement may contain any provisions for the regulation and management of the affairs of the Company not inconsistent with these Articles of Organization, or Chapter 605, *Florida Statutes*.

ARTICLE VI - Initial Registered Agent and Office:

The initial registered agent for the Company shall be John Steven Hamilton and the street address of the Company's registered agent is 192 NE Cypress Trail, Jensen Beach, FL 34957.

ARTICLE VII - Amendments:

The Company reserves the right to amend any provision of these Articles of Organization, which amendment shall be approved in the manner set forth in the Operating Agreement of the Company.
