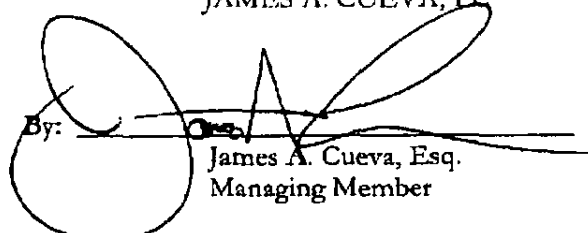

**ARTICLE V: Number of Membership Units**

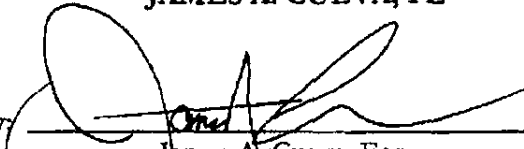
