AMENDED AND RESTATED
ARTICLES OF ORGANIZATION
OF
NOWAKOWSKI, LLC

This Limited Liability Company was originally organized as NOWAKOLSKI LLC and filed its Articles of Organization on August 18, 2014 with the Department of State and was assigned document number L14000129390, and now by consent of all of the Members hereby amends and restates its Articles of Organization as follows:

ARTICLE I

NAME AND ADDRESS
