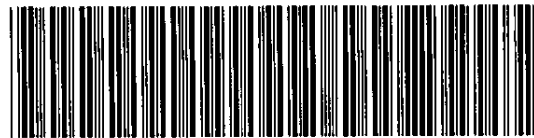



**ARTICLES OF AMENDMENT
TO
ARTICLES OF ORGANIZATION
OF

The undersigned, pursuant to the provisions of Chapter 605, Florida Statutes, provides the following information for the purpose of amending the Articles of Organization of **SEASONS HOSPICE & PALLIATIVE CARE OF BROWARD FLORIDA, LLC**, which was formed under the laws of the State of Florida pursuant to Articles of Organization originally filed with the Department of State on August 18, 2014, and assigned document number L14000129470.

1. Article 4, **Management**, of the Articles of Organization is amended to read:

**ARTICLE 4
Management**

The Limited Liability Company shall be a manager-managed company, with one or more managers as determined by the Company.

Pursuant to Section 605.04073, F.S., and in accordance with the Operating Agreement of the Company, all of the Members authorized and consented in writing to these Articles of Amendment to Articles of Organization. The vote was sufficient for approval.


