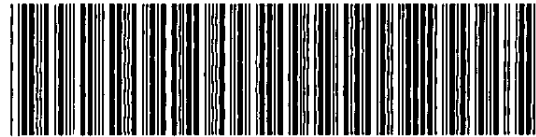

The name of the Limited Liability Company is "**TT of NAS, LLC**" (the "**Company**").


**Article II.
