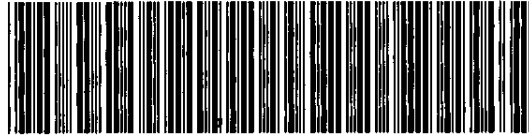

FORT SUMMIT INDEPENDENCE CAMPGROUND, LLC**


