

**ARTICLES OF ORGANIZATION
OF AWA MORTGAGE MAINTENANCE SERVICES LLC**

These Articles of Organization are made for the purpose of organizing a Florida Limited Liability Company under the Florida Limited Liability Company Act (Florida Statutes Chapter 605).

Article 1 – Name

The name of this limited liability company is AWA MORTGAGE MAINTENANCE SERVICES LLC ("Company")

Article 2 - Duration

The Company shall exist from the date of filing these Articles with the Department of State until the earlier of thirty (30) years from the date of filing or the occurrence of any of the events specified in Florida Statutes Section 605, unless continued by the remaining members pursuant to the Company's Operating Agreement.
