ARTICLES OF AMENDMENT
TO
ARTICLES OF ORGANIZATION

Pursuant to the provisions of Chapter 605 of the Florida Statutes, the undersigned hereby declares the following amendment (the "Amendment") was adopted to the Articles of Organization of HORSEHEAD NEBULA, LLC, a Florida limited liability company ("the Company") originally filed with the Secretary of State, State of Florida on August 27, 2014 and assigned Florida document number L14000134682:
